I, (print full name) _____, (hereby referred to as adopter) am willingly adopting the above mentioned cat (hereby referred to as the cat) as a pet for myself and/or my immediate family from The Cat's Meow Rescue (hereby referred to as TCMR). I agree to provide food, shelter, attention and medical care as needed to ensure the safety and well being of the cat. I understand that adopting the cat is a long-term commitment and will fulfill that obligation to the best of my ability for the duration of the cat's natural life. I agree that I will not sell, give away or otherwise dispose of the cat to any person(s), dealer, retailer, auction, institute or any other entity for any reason. If for any reason I cannot continue to care for the cat or must re-home the cat, I understand that I must contact TCMR and agree to return the cat to TCMR. I understand that any adoption fees or money otherwise spent on the cat will NOT be reimbursed to me by TCMR. (initial) _____

I agree to take the cat to a vet/clinic of my choosing for a wellness check-up and/or vaccines (if needed) within 30 days of the adoption to ensure the cat is healthy and protected from transmittable diseases. I understand that if the cat is not already spayed/neutered, that it is my responsibility and agree, when the cat is of appropriate age (6 months or at the recommendation of my vet), to get the cat spayed/neutered. I understand that (if applicable) TCMR provides a spay/neuter voucher to assist with the spay/neuter cost for the cat. I understand that I may use any vet or clinic of my choosing to spay/neuter my pet and agree to pay any amount in excess of the voucher or the full amount of the spay/neuter if my vet does not accept the provided voucher. I understand TCMR does not condone the declawing of cats and I agree that I will NOT declaw the cat. (initial) _____

I understand the cat I am adopting is an INDOOR ONLY cat and that, for the safety and well-being of the cat, I WILL NOT let the kitty outside for any reason at any time. (initial) _____

I understand and agree that TCMR makes no representations or warranties, expressed or implied, about the cat's temperament and is hereby absolved from any liability for future damages or injuries caused by the cat. I also understand and agree that TCMR gives no guarantees, expressed or implied, about the cat's health and is not responsible for any future medical costs incurred by the cat. I agree to assume all responsibility for the treatment of all existing conditions or any other conditions or physical changes that may occur. (initial) _____

TCMR reserves the right to follow up on this adoption, to physically check the cat's condition, and that this contract is authorization to contact and speak to your vet(s) and to receive copies of medical records from them. (initial) _____

This is a legally binding contract. I agree that all statements I have made on this form are true. If it is found that any statements I have made on this form are not true or I fail to meet the requirements established in this agreement, TCMR can immediately confiscate the cat without a refund of adoption fees or other costs incurred by me.
